## WHAT DOES PEAPACK PRIVATE BANK & TRUST AND ITS AFFILIATES DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Transaction history and credit history

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Peapack Private Bank & Trust and its affiliates chooses to share; and whether you can limit this sharing.

| <b>How does Peapack Private Bank &amp; Trust and its affiliates protect my personal information?</b> | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.   |
| <b>How does Peapack Private Bank &amp; Trust and its affiliates collect my personal information?</b> | <p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>- open an account or deposit money</li> <li>- pay your bills or apply for a loan</li> <li>- use your credit or debit card</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>  |
| <b>Why can't I limit all sharing?</b>  | <p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>- sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>- affiliates from using your information to market to you</li> <li>- sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p> |
| <b>What happens when I limit sharing for an account I hold jointly with someone else?</b>            | Your choices will apply to everyone on your account   |

| <b>Affiliates</b>      | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>- <i>Our affiliates include companies with a Peapack Private Bank &amp; Trust or PGB name; financial companies, such as Peapack Capital Corporation; Peapack-Gladstone Mortgage Group Inc.; PGB Trust &amp; Investments of Delaware; Peapack Ventures LLC; Peapack-Gladstone Realty Inc.; PGB Securities Inc.</i></p> |
| <b>Nonaffiliates</b>   | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>- <i>Peapack Private Bank &amp; Trust and its affiliates do not share with nonaffiliates so they can market to you.</i></p>   |
| <b>Joint marketing</b> | <p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>- <i>Our joint marketing partner(s) include financial services and credit card companies.</i></p>  |

**Other important information**
**Special Notice For California Residents**

Under California law, Peapack Private Bank & Trust and its affiliates will not share information Peapack Private Bank & Trust and its affiliates collect about California residents with companies outside of our corporate family, unless the law allows. Peapack Private Bank & Trust and its affiliates will limit sharing among our companies to the extent required by California law.

**Special Notice For Vermont Residents**

Under Vermont law, Peapack Private Bank & Trust and its affiliates will not share information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures. Peapack Private Bank & Trust and its affiliates will limit sharing among our companies to the extent required by Vermont law.
